- (2) Were found to be having deficiencies during the last point & crossing drive.



PCSOs may also critically analyze complete shortcomings to identify systemic deficiency and action taken/planned to be taken should be sent to the Board daily by 9:00 am. PCSO's may keep the record of inspections of each Point & Crossing and submit the same after the drive to the board by 06.05.2025. Apart from sending hard copy, the report should invariably be uploaded on SMDMS, both in PDF and DOC format and may also be e-mailed at edeasafety@gmail.com and safetvimp46@gmail.com.
